

## LIMITED WARRANTY AND SOFTWARE LICENSE AGREEMENT READ BEFORE OPENING

**THIS IS A LEGAL AGREEMENT** between you and Euphonix, Inc. ("Euphonix"). **If you do not agree to the terms of this agreement, please promptly return the Product and accompanying items to Euphonix with proof of purchase for a full refund.** Otherwise, by using the Product provided by Euphonix, you agree to be bound by the terms of this agreement.

**LIMITED WARRANTY:** Euphonix warrants, subject to the limitations set forth below, that this Product and any media on which Euphonix furnishes software (including upgrades) for the operation of the is free from defects in material and workmanship for a period of one (15) months from the date of shipment to you. This warranty does not cover cost of removal or reinstallation, cosmetic damage, or damage due to acts of God, accident, misuse (including inadequate maintenance), abuse, negligence, modification of the Product, incorrect environments, improper storage, or incorrect installation or servicing not performed by Euphonix. This warranty only applies to the original end-user purchaser as evidenced by the end-user's bill of sale.

**LIMITATION OF REMEDY: Euphonix's entire liability and your exclusive remedy is, at Euphonix's sole option, for Euphonix to replace or repair the Product.** The Product and all accompanying items must be returned to Euphonix with proof of purchase. **LIMITATION OF WARRANTY:** TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, EUPHONIX DISCLAIMS ALL OTHER WARRANTIES, EITHER EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE AND ANY WARRANTY AGAINST INFRINGEMENT. EUPHONIX DOES NOT WARRANT THAT THE FUNCTIONS CONTAINED IN THE PRODUCT (INCLUDING ANY SOFTWARE) WILL MEET YOUR REQUIREMENTS, OR THAT THE OPERATION OF THE PRODUCT (INCLUDING ANY SOFTWARE) WILL BE ERROR-FREE, OR THAT ALL DEFECTS WILL BE CORRECTED.

You may not copy the printed materials accompanying the Software, nor print more than one copy of any user documentation provided in "online" or electronic form. Euphonix reserves all rights not explicitly granted in this agreement. Euphonix may terminate this License if you fail to comply with the terms of this agreement.

**GENERAL:** This agreement is governed by the laws of the United States and the State of California, without reference to conflict of laws principles. This agreement is the entire agreement between you and Euphonix and supersedes any other communication or advertising with respect to the Product (including any software) and accompanying items. If any provision of this agreement is held illegal, invalid or unenforceable, the remainder of this agreement shall continue in full force and effect.
